Chair Simmons read the following notice,

The purpose of this public hearing is to allow members of the public to make comments on the 2023 proposed budget. Please note that it is only a proposed budget until the Board of Fire Commissioners adopts the final budget.

The Notice of Budget Hearing was published in the Journal News on October 13, 2022, and it was posted on the Fire District website and signboard from September 30, 2022, through October 18, 2022. The notices specified the time, date, and place where this public hearing would be held.

A copy of the notice of Budget Hearing was submitted to the Town Clerk of the Town of Greenburgh for posting on the Town website and signboard from October 3, 2022, through October 18, 2022.

A copy of the proposed budget was posted on the Fire District website and was available for inspection in the Office of the Fire District Secretary and the Office of the Town Clerk.

Chair Simmons presented the proposed budget of the Fairview Fire District for the year 2023.

Chair Simmons stated that the public comments period now begins. She asked that anyone wishing to speak clearly state their name for the record and limit their comments to five (5) minutes.


There were three (3) members of the public present.

The public comments period was concluded at 18:10


The Chair announced that the final budget for the year 2023 would be adopted at the regular meeting immediately following this budget hearing.
