### Health & Safety

## R21-11-06

Upon the motion offered by Commissioner Yizar and seconded by Commissioner Walthall-Moon that the sum of \$1,775 shall be paid to All-Pro Restorations of Elmsford, NY for the cleaning, sanitizing, and disinfecting the HVAC units and ductwork at Headquarters and Station 2:

There is an ongoing discussion amongst neighboring Departments about the potential need for individual regulators for Scott Packs. We are looking into applying for a federal grant with other local departments for funding these regulators.

Commissioner Simmons suggested reaching out to Winsome Gordon of the Town of Greenburgh, as she has excellent experience writing successful grants.

## Chief's Report

#### R21-11-07

Upon the motion offered by Commissioner Simmons and seconded by Commissioner Walthall-Moon that the Board approves FF Padraic Murray's attendance at the Westchester County Fire Training Center, Firefighter Training Series from 16 November 2021 to 20 December 2021 at no cost to the District:

Michael Murray is scheduled to attend First-Line Supervisor School with FDNY from 3 January 2022 to 28 January 2022 in accordance with his promotion to Fire Captain. The course will be held at Fort Totten in NYC.

Metropolis Country Club Member's Association was gracious in donating \$10,000 to the Department. We discussed using the donation to replace defibrillators, and DC DiGilio is currently researching.

### R21-11-08

Upon the motion offered by Commissioner Yizar and seconded by Commissioner Walthall-Moon that the Board approves the purchase of two(2) 100' lengths of 4-inch Supply Hose and six(6) 50' lengths of 2-inch hose at the total cost of \$2,964:

Recently, there has been an increase in businesses charging a credit card fee on top of the purchase cost. The fee is usually about 3.5%, and the Department is doing their best to avoid them where possible.

On 25 October, 16 members attended Hazmat training with the county. On 8 November, Captain Lester and Firefighters Lowrey, Zima, and Theile participated in the Squad drill. Both drills went well.

The Fall training days are in progress, Groups 1 and 3 participating on 29 October. Groups 2 and 4 have their training on 12 November. Members are being trained on Thermal Imagining Cameras.

Commissioners Malone and Simmons and department members attended the Westchester County Memorial Service on 17 October, where FF Robert Mentransti was honored with his name being added to the wall.

Chief Reiss expressed his gratitude to the Board for allowing the Department to host the memorial service for retired FF David Pagliaroli on 21 October. It was well attended, and the family was very appreciative. The Department received a thank you card for the Board members that attended and Commissioner Simmons for her kind words.

## R21-11-09

Upon the motion offered by Commissioner Simmons and seconded by Commissioner Walthall-Moon that the Board shall approve that the equipment set forth below shall be declared surplus:

On 17 October, the Fire Prevention trailer was sent to Scarsdale for an event. On 31 October, the Department sent an Engine and participated in the Parkway Gardens Halloween event. On 11 November, an Engine was sent to the Veteran's Day Service at Desanti Park in Hartsdale.

The Department responded to 227 alarms in October 2021, including 120 EMS and Extrication calls, 7 mutual aid-out responses, and 6 mutual aid-in responses.
