Chief's Report

Probationary Firefighters Wayne Jones and Tyler Cowles are both excelling at the Career Fire Academy. The Graduation is scheduled for January 18, 2023, at the Westchester Community College auditorium.

Firefighter Derrick Bert has retired as of 28 November 2022.

The Firefighter Exam is scheduled for February 2023, the Department will be hosting an exam prep series at the Theodore D. Young Community Center on January 11th, 18th, and 24th and February 1st, and 8th.

The 4th quarter Officer's meeting took place on December 13th, and the topic of the meeting was to update the Department's Standard Operating Guidelines.

The Department responded to 217 alarms in November 2022, including 128 EMS and Extrication calls, 15 mutual aid-out responses, and 6 mutual aid-in responses.

End of Chief's Report

The Secretary reported that the Annual Election took place on 13 December 2022 at Fairview Fire Headquarters and Fairview Fire Station 2 from 4:00 pm to 9:00 pm, prevailing time. There were a total of 27 votes cast. Vikki Simmons received 27 votes.
