Apparatus Committee

House & Grounds Committee

Commissioner Walthall-Moon provided paint swatches, carpet samples, and new chair options for the ongoing Headquarters Board room project.

An exploratory committee for an extension on the Headquarters Apparatus Bay may be necessary. The current apparatus bay will not accommodate a new ladder truck, and an expansion could allow for building on top for a potential second-floor extension. The Committee should meet with an architect to discuss the specifics.

There are discussions to renovate the HQ basement to enhance the gym, locker room, and bathrooms while maintaining a meeting space.

Spring training days are in the process of being planned. Water rescue is being considered as the training topic. The Department is considering using the Theodore D. Young Community Center pool.

Members have resumed monthly Technical Rescue training with Greenburgh Police Department, Greenville Fire Department, and Hartsdale Fire Department. February's training was Ice Rescue, March's training was Rope Rescue.

The Probationary Firefighters started work on 8 March 2022 and are scheduled to being the 18-week Fire Academy on 15 March 2022.

The Chief will attend a meeting tomorrow, 11 March 2022, held by the Westchester Putnam Central Labor Body. The meeting topic is the regional consolidation of Pelham, Pelham Manor, Larchmont, and New Rochelle Fire Departments.

The 32 SCBA regulators purchased from Municipal Emergency Supplies were delivered. The Department is currently in the process of inventorying and labeling each unit.



The Chief attended a meeting regarding the County's purchase of a new Squad 6 vehicle. The Chief said he would prefer it if the County Purchased a box truck with a lift gate.

Westchester County DES has communicated information regarding their Hazmat and Technical Rescue teams. They are looking for assistance with those teams' responses.

On 4 March 2022, we provided a mutual aid response to a house fire in Scarsdale. Captain Murray and Firefighters Crump, Peterson, and P. Murray performed exceptionally.

The Department responded to 177 alarms in February 2022, including 90 EMS and Extrication calls, 12 mutual aid-out responses, and 3 mutual aid-in responses.
