WHEREAS, the Board of Fire Commissioners of the Fairview Fire District held the annual fire district budget hearing on notice to the public on October 20, 2020, and

WHEREAS, the Board has considered the proposed budget and comments received on the proposed budget on October 20, 2020, at said budget hearing, and

NOW, THEREFORE, BE IT RESOLVED, that the Final Budget for the Fairview Fire District for the year 2021 in the amount of \$13,807,684.00 is hereby approved and adopted, a copy of which shall be attached hereto, and shall be submitted to the Town of Greenburgh.


