The regular meeting of the Board of Fire Commissioners of the Fairview Fire District, Westchester County, New York, of Thursday, 10 December 2020, convened at 19:34 hours at Fire Headquarters at 19 Rosemont Boulevard, Greenburgh, New York, in a remote format. Upon the motion offered by Commissioner Walthall-Moon and seconded by Commissioner Yizar that the meeting shall be called to order:

Roll call: Commissioners Yizar, Malone, Walthall-Moon, Robinson, and Simmons voting aye, nays none, none absent. The motion was carried.

Chair Simmons called the roll: Commissioners Yizar, Malone, Walthall-Moon, Robinson, and Simmons present.

Upon the motion offered by Commissioner Yizar and seconded by Commissioner Malone that the minutes of the regular meeting of 12 November 2020 shall be approved with correction by the Secretary: Roll call: Commissioners Yizar, Malone, Walthall-Moon, Robinson, and Simmons voting aye, nays none, none absent. The motion was carried.

Apparatus Committee

The 2000 KME Excel has been delivered to the purchaser.

Car 2122 has been delivered by Hudson Valley Fire Equipment on Wednesday, 9 December. The vehicle is expected to be in service next week.

The 2011 Spartan Rescue is in conversation to sell to East Eden Fire Company for \$70,000.00

Chief Reiss stated that both the House & Ground and Finance Committee meetings were canceled due to COVID-19

The Secretary reported that the annual Fire District election was held on 8 December 2020 at Fairview Fire Headquarters and Fairview Fire Station 2 from 4:00 p.m. to 9:00 p.m., prevailing time. There were a total of 72 votes cast. James Robinson received 72 votes.

The Board agreed that the End of Year meeting would be held on 28 December 2020 at 10:00 a.m. and the 2021 Organizational Meeting would be held on 14 January 2021 at 6:30 p.m.

Commissioner Malone expressed interest in the Board conducting their meetings in-person in the coming year. There was a lengthy discussion in which Commissioner Simmons noted that we are still in the middle of the COVID-19 pandemic. The Board agreed to make the best decision for everyone's health and safety.

2020 Training days have been completed. All members received a full day of pumping and operations training and a full day of emergency vehicle operations and driving training. Each member will continue to train on the new apparatus.

Chief Reiss expressed his gratitude to the Board and the Apparatus Committee for purchases of the Segrave pumpers.

Westchester County has appointed former County Legislator Richard Wishie as Commissioner of the Department of Emergency Services, replacing Commissioner John Cullen. The Chief will reach out to schedule a meeting to discuss the future of Westchester's Emergency Services



Verizon is working on getting generators for their towers. They have finished replacing the gas line and restoring the sidewalk they cut in the process.

The 4th Quarter Officer Meeting took place on Wednesday, 9 December 2020. The new response matrix was discussed. We will no longer respond with Rescue 3. The tour commander will respond in Car 2122; this changes the dynamic of the Station 2 response. We anticipate having the full plan to the County in the coming weeks.

COVID-19 was also the subject of the meeting. We discussed resources and the necessary steps to keep the members safe. There will be ongoing station disinfection, proper usage of PPE, and decontamination post alarms.

Together with Chief Spedaliare from Greenville and Chief Maseda from Hartsdale, we have reorganized the Sprain Brook Parkway response. The solution was amicable for all parties.

Chief Reiss reported the passing of retired Captain Kenny Peluso. He expressed that his death is a significant loss. Captain Peluso was a joy to know. His arrangements will be in Florida.

The Santa Claus detail will still happen this year. We will not be doing stops in each neighborhood to avoid crowds of people congregating in one location. We are going street by street through the district in the early evening hours.

On December 5th, the Department responded to a multi-family building structure fire in Ardsley. The Fairview members did an outstanding job as the FAST team.

On November 18th, the Chief participated in the State Chiefs Meeting via Zoom. He also participated in a Zoom panel with 'Ray and Associates' regarding the search for a new Greenburgh Central 7 Superintendent. On December 8th, he participated in a Westchester Career Chiefs meeting via Zoom.

Since the last meeting, the Department has participated in 4 birthday drive-bys. On October 31st, we participated in the Parkway Gardens and Parkway Homes Halloween event. On November 11th, we attended the Veterans Day Ceremony at Desanti Park.

The Department received a letter from Retired Captain Claude Morgan congratulating us on acquiring the new Seagrave Twin Pumpers.

The Department responded to 175 alarms in November 2020, including 78 EMS and Extrication calls, 8 mutual aid-out responses, and 12 mutual aid-in responses.

End of Chief's Report

Commissioner Yizar inquired about the Westchester Department of Emergency Services appointment. The Chief stated that the new Commissioner is not the same person that had been previously discussed.
