The Fire District net total is \$70,000:

The Committee has started to research the value of the Ahrens Fox antique. The Reliance Fire Museum estimated that, at auction, the truck could potentially sell for between \$40,000 and \$50,000.

# Chief's Report

Due to COVID-19, external department training is off to a slow start. The 2021 Annual Andy Fredericks Seminar, usually held in Elmsford, was postponed until 2022.

Code Enforcement in-service training, which usually begins in March, was postponed until June.

2021 Sexual Harassment and Workplace Violence has been made available.

As head of the Westchester County Career Fire Chiefs Organization, Chief Reiss met with the newly appointed Department of Emergency Services Commission Richard Wishnie and Deputy Commissioner Susan Spears on 13 January 2021. The meeting went very well, and they both seem to be very motivated in their new positions.

Group changes for 2021 have been implemented.

The Department is currently at full staff in regards to COVID-19. The Chief reported that approximately 70% of the membership has begun the vaccination process for the virus.

Car 2122 is in-service. All dispatch protocol has been updated with 60 Control.

Association of Fire Districts of the State of New York has scheduled the annual conference and meeting for May 2021 in Verona, New York,

Hartsdale Fire District Commissioner Peter Woods has passed away. Commissioner Woods was a retired FDNY Sergeant and 9/11 first responder.

The Santa Claus detail went very well. The career and volunteer staff assisted and made it a success.

Chief Reiss attended a meeting with Greenburgh Housing Authority via Zoom on 30 December 2020 to discuss Knox Box access.

The Department responded to 196 alarms in December 2020, including 76 EMS and Extrication calls, 17 mutual aid-out responses, and 7 mutual aid-in responses.

In 2019, the Department responded to 2,193 alarms, 1,060 EMS and Extrication calls, 119 mutual aid-out responses, and 85 mutual aid-in responses.

End of Chief's Report

Commissioner Walthall-Moon expressed that she feels the website should have more information regarding what is going on with the Department. She said the members do many great things that the Fairview community may not be aware of.
